## Keeping the Public Informed: Administrative Ready Reference

The long-awaited update of *Keeping the Public Informed: Administrative Ready Reference* is available at <http://il.webjunction.org/readyref/>.

When the Administrative Ready Reference CD product was released in 1999, it was considered a valuable support resource for public libraries and trustees. The new 2009 edition includes updates of key resources and introduces a new interactive platform for the exchange of information, ideas and practices within the Illinois library community. In addition to the documents, which are available in various file formats, the new version of Administrative Ready Reference resides within the larger WebJunction Illinois

repository of documents and services.

To be eligible for an FY2010 Public Library Per Capita Grant from the State Library, public library staff and trustees are required to review the Administrative Ready Reference. Libraries that have already reviewed the previous ARR as part of the grant process do not need to review the updated version.

Thanks to the Shawnee Library System for managing the update. Funding for the project was awarded by the State Library using funds from the federal Institute of Museum and Library Services under the Library Services and Technology Act.

## E-RICH update

E-RICH, the State Library's electronic resource service, will no longer offer subsidized or negotiated pricing for electronic resources for direct library purchases beginning **July 1, 2010**. Notwithstanding, the State Library will continue to subsidize and provide FirstSearch at no charge to ILLINET libraries. E-RICH will continue to offer Try-It! Illinois, the annual electronic database trial, and the Electronic Resource Exposition (E-R-XPO) to ILLINET libraries.

The online readers' advisory service is available to ILLINET academic, public, special and high school library buildings as well as middle and elementary library buildings. ## Read for a Lifetime draws nearly 1,000 students

Statistics for the 2008-09 Read for a Lifetime program, the State Library's reading program for high school students, have been released. Nearly 1,000 students from across the state participated and collectively read nearly 4,700 books over the course of the school year.

- 988 students (and five adult library staff members) from 72 Illinois high schools and public libraries read 4,692 books.
- 68 high school seniors received four-year participation certificates.
- Six students read all 25 titles on the reading list.
- The top five most read books were: *Sold*; *Just Listen*; *Nineteen Minutes*; *Red Kayak*; and *How to Ruin a Summer Vacation*.

Ask?Away Illinois, the statewide virtual reference service, now has a group on WebJunction Illinois. The group includes information about staffing, marketing, training and participating in Ask?Away. ### Barry Levine 1949-2009

The State Library and the Illinois library community lost a dear friend in April when Barry Levine passed away suddenly. Barry was diagnosed with retinitis pigmentosa as a youth and lost his sight in his late 20s. Despite being legally blind, he was active in local, state and national library services.

Barry was a member of the Illinois State Library Advisory Committee for six years, serving as chair in 2008. He also was a founding member of the State Library Talking Book and Braille Service Committee, a position he held for eight years until his death. Barry also served as president of the Prairie Area Library System and vice president of the Homer Township Public Library Board of Trustees. As a Homer Library trustee, Barry was instrumental in expanding the library's collection of large-print and audio books to its current size of more than 5,000 items. He also supported establishment of Homer Township Library's Bookmobile service and campaigned for an ADA accessible station and computer for low-vision patrons at the library.

Barry's leadership and efforts earned him the Illinois Library Association's Trustee of the Year Award in 2001 and the Alexander J. Skrzypiek Award in 2004, given to those who make outstanding contributions in the advancement of library service for the blind and physically disabled in Illinois.

We offer our sincere condolences to Barry's wife Phyllis and children Randon, Rachael and Sarah. Barry was truly one of a kind, and he will be deeply missed.

## State Library provides continuing education opportunities in June

**Small Public Library Management Institute** — Sponsored by the State Library and hosted by the University of Illinois at Springfield, the Small Public Library Management Institute was held May 31-June 5 and drew 48 Illinois library directors from across the state. The theme this year was “Serving Your Public.”

The institute is designed for directors of smaller public libraries and directors new to the Illinois library community, and assists participants in developing and enhancing their administrative and leadership skills. Topics included leadership and teamwork, personnel and customer service, the First Amendment, Illinois library law, security issues, dealing with problem patrons, grant writing, technology and director/trustee relations.

**Institute for School and Public Librarians** — The following week, June 7-12, 54 Illinois librarians took part in the Institute for School and Public Librarians, sponsored annually by the State Library and hosted by Bradley University in Peoria. The theme this year was “Linking, Learning and Libraries.”

The institute focuses on developing programs, delivering library services and selecting resources based on the various information needs of communities across Illinois. Topics included the value of partnerships (especially between public and school libraries) and using technology to access information and educational resources; multicultural materials; intellectual freedom and collection development; removing old or outdated books from libraries; using technology to promote books; Internet safety; copyright issues; and grant writing, among others. Funding for the institute is awarded by the State Library using federal Institute of Museum and Library Services funds under the Library Services and Technology Act.
